- Prizes for Champion in all divisions.
- ASTM-SEI approved helmets must be worn at all times
- Martingales are not permitted in under saddle classes, equitation flat classes, or the flat phase of a Medal classes.
- Unconventional hunter tack or equipment will only be permitted at the judge's discretion.
